Note:

Immunization Technical Support Unit (ITSU) is strategic arm of Ministry of Health and Family Welfare (MoHFW) that works towards strengthening of Universal Immunization Program (UIP).

Program Operation & Monitoring (PO & M) division of ITSU reviews the reported data on Child Immunization (service delivery) that captured in Health Management Information System (HMIS) and Mother and Child Tracking System (MCTS). PO &M division of ITSU develops immunization dashboards and provide state specific feedback on monthly basis by analyzing the data. Dashboards provides state wise performance on various immunization component (timeliness, coverage, AEFI, training, VPD cases, etc.) and concurrent feedback regarding reported Immunization data to MoHFW, partner organizations and immunization program managers at state level. Additionally these dashboards collate data provided by WHO-NPSP (World Health Organisation – National Polio Surveillance Project) and NCCVMRC- NIHFW (National Cold Chain & Vaccine Management Resource Center – National Institute of Health & Family Welfare) related to concurrent monitoring and Immunization trainings.

The PO&M division adheres to the fixed timeline (after 20th of every month) for reviewing the immunization data uploaded onto the HMIS, and MCTS portals. As per the HMIS guidelines, it's mandatory for all the states to upload monthly data of the preceding month on or before the 20th of each month. Thus 20th is considered the threshold for ensuring timely reporting within the HMIS. On a monthly basis, a group of states receives detailed feedback on Immunization coverage and data quality issues. The following table explains the framework for categorization of states and union territories that the PO&M division at ITSU follows for providing the feedback.

This feedback cycle is repeated on quarterly basis:

First month : Assam, Bihar, Chhattisgarh, Jharkhand, Madhya Pradesh, Odisha, Rajasthan, Uttar Pradesh &

Uttarakhand.

Second Month: Andhra Pradesh, Arunachal Pradesh, Delhi, Haryana, Gujarat, Jammu & Kashmir, Manipur,

Meghalaya, Mizoram, Nagaland, Tripura and West Bengal.

Third Month : Andaman & Nicobar Island, Chandigarh, Dadra & Nagar Haveli, Daman & Diu, Goa,

Himachal Pradesh, Karnataka, Kerala, Lakshadweep, Maharashtra, Puducherry, Punjab,

Sikkim and Tamil Nadu.

Immunization dashboards aim to improve quality and use of reported data on immunization for concrete programmatic action for addressing the challenges in strengthening UIP.

KEY FACTS

HMIS IMMUNIZATION DATA FOR OCTOBER 2014

HMIS Portal as on 24 November 2014

0 – 11 Months Vaccination

Till October 2014, the nation's full immunization coverage (FIC) was 49.9% against the expected figure of 58.3% for 7 months. The national coverage for BCG, DPT3, Penta3, MCV1, JE1 were 51.3%, 49.0%, 49.8%, 50.4% and 32.2% respectively.

- States / UTs that reported FIC more than the expected 58.3% are Telengana (70.9%), Mizoram (61.0%) and Punjab (60.0%); Arunachal Pradesh reported 34.9% coverage, which was the lowest in the country.
- States / UTs that have reported BCG coverage more than the expected 58.3% are Puducherry (103.8%), Chandigarh (88.2%), Mizoram (77.2%), Meghalaya (71.3%), Manipur (67.4%), Punjab (60.1%), West Bengal (60.1%) and Telengana (59.5%) while Lakshadweep (36.1%) and Daman & Diu (39.5%) are the two lowest reporting states / UTs.
- States / UTs that have reported DPT3/Penta3 coverage more than the expected 58.3% are Mizoram (66.6%), Meghalaya (64.2%), Manipur (63.6%), and Tripura (59.9%) while Puducherry reported only 35.3% Penta3 coverage and Arunachal Pradesh reported 35.5% DPT3 coverage. Andhra Pradesh, Bihar, Chandigarh, Maharashtra and Sikkim reported data related to pentavalent though these states are not giving pentavalent vaccine as per state UIP schedule.
- Most JE-endemics states / UTs reported very low coverage of JE-1st dose, such as Kerala (6.0%), Jharkhand (6.0%), Telengana (6.4%), Arunachal Pradesh (13.2%), Andhra Pradesh (16.9%), Manipur (26.2%), Maharashtra (27.7%), Uttar Pradesh (29.5%), Assam (36.6%), Nagaland (40.3%) and West Bengal (41.9%) against 58.3%.
- ▶ States / UTs that reported MCV1 coverage more than the expected (58.3%) coverage were Lakshadweep (65.3%), Mizoram (62.3%), Delhi (61.9%), Punjab (60.7%), Meghalaya (60.6%), Tripura (60.3%), Goa (60.2%), Telengana (59.5%), Manipur (59.4%) and West Bengal (59.2%), and Arunachal Pradesh reported lowest MCV1 coverage (37.1%).

Hep B birth dose is given within 24 hours of birth and is mandatory for all institutional deliveries; however, in only 64.4% of institutional deliveries Hep B birth dose is given in the country. Andhra Pradesh reported more than 131.8% coverage while Manipur (27.3%), Kerala (34.0%) and Mizoram (35.1%) are three lowest reporting states / UTs.

12-23 Months Vaccination

- ▶ Till October 2014, the national coverage for MCV2 was only 32.0% against the expected 58.3%, while the coverage for DPT booster and JE second dose (in JE-endemic districts) for the same period was 42.1%, and 52.9% respectively.
- ▶ Kerala reported 1.2% coverage for MCV2 and Arunachal Pradesh reported the lowest DPT booster coverage at 25.8%. Jharkhand reported lowest (3.2%) JE 2nd dose coverage from JE-endemic districts. Kerala over reported the JE 2nd dose coverage (1396.1%).

Drop-out Rate (DPT1/Penta1 – DPT3/Penta3)

- Till October 2014, the national drop-out rate for DPT1/Penta1 DPT3/Penta3 was -2.7%. In states/ UTs using Pentavalent, drop-out rate between the first and the third dose is 3.0% whereas this rate in states/ UTs using DPT is 1.8%. Negative drop out means that the reported DPT3/Penta3 coverage is higher than the DPT1/Penta1 coverage.
- States / UTs that reported negative drop-out are Andhra Pradesh, Bihar, D & N Haveli, Daman & Diu, Goa, Himachal Pradesh, Lakshadweep, Odisha, Punjab, Telengana and West Bengal.

Other feedback

The country continues to be polio free for more than three years; however, the HMIS data pertaining to polio case reporting remains an issue and needs immediate attention at all levels. In India 588 polio cases (568 from Gujarat, 15 from Rajasthan, 4 from Uttarakhand and 1 from Nagaland) were reported till October 2014 in HMIS data.

WHO-NPSP CONCURRENT MONITORING DATA

Till October 2014

- ▶ Lowest percentage of children fully immunized: Punjab (55.1%).
- ▶ State with high percentage of planned immunization sessions not held: Haryana (11.9%).
- State with high percentage of immunization sessions where due list was not available: Punjab (46.5%) and Uttarakhand (45.3%).
- State with high percentage of immunization sessions where all vaccines were not available: Tamil Nadu (79.8%), Kerala (56.4%) and Rajasthan (53.7%).

MCTS PORTAL DATA FOR YEAR 2014-15

As on 29th October 2014

- ► Only 57.5% of data entry for infant was done for the year 2014–15 on pro-rata basis at MCTS portal as on 24th November 2014, with lowest 29.9% being in Arunachal Pradesh.
- ▶ Percentage of villages not mapped with any facility at MCTS portal: Total of 38.23% villages were not mapped in India. Rajasthan (100.0%) and Puducherry (97.6%) have the highest percentage of villages not mapped at MCTS portal.
- All-India coverage for FIC is just 1.1%. Only Rajasthan, Karnataka, Chhattisgarh and Tamil Nadu reported more than 1% coverage.
- ► Antigen-wise all-India coverage against registered children in 2014–15:
 - Hep B birth dose: 38.56% (Assam, Meghalaya, Gujarat, Manipur, Chhattisgarh and Uttar Pradesh reported less than 20% coverage)
 - BCG: 69.75% (Bihar, Assam, Rajasthan and Uttar Pradesh reported less than 60%).
 - DPT3: 15.45% (Haryana, Goa, Gujarat, Kerala, Puducherry, J&K and Delhi less than 1% coverage)
 - Measles 1st dose coverage is just 1.25%. Only Rajasthan, Tamil Nadu, Chhattisgarh and Karnataka reported more than 1% coverage.








FULL IMMUNIZATION COVERAGE

Till October 2014 - Year 2014-15 (58.3% annulised)




HEPATITIS B BIRTH DOSE COVERAGE

(Against Ins. Delivery) Till October 2014, Year 2014-15




MCV2 COVERAGE

DATA OCTOBER 2014 (9 STATES)

Assam

- Low coverage of Hep B Birth dose (36.1%) against institutional deliveries.
- ♦ Low coverage of Measles second dose (38.2%) and DPT Booster (41.8%), JE 1st (36.6%) and JE 2nd (32.4%) against expected (58.3%).
- State is also reporting the immunization data on MMR (472 doses) till Oct 2014, though MMR is not a part of UIP program in the state.

Bihar

- Total 3 Districts (Araria, Sheikhpura and Seohar) out of 38 districts did not report for the month of Oct-14.
- ♦ Low coverage of DPT1 (45.6%), Measles first dose (46.2%), Measles second dose (30.7%), FIC (45.0%), DPT Booster (35.6%) and JE 2nd Dose (44.5%) against expected (58.3%).
- DPT1-DPT3 dropout rate is negative (-4.0%) from Arwal (-16.2%), Bhagalpur (-13.5%), Banka (-13.2%), Jehanabad (-12.4%), Kaimur (-10.9%), Purnia (-10.9%), Aurangabad (-10.5%). Negative drop out means that the reported DPT3 coverage is higher than the DPT 1 coverage.
- State has reported 229 Cases of Diptheria, 233 Cases of Pertusis till Oct-14 which is third highest in the country and 333 cases of Tetanus Neonatarum till Oct-14 which is second highest in the country.
- State is also reporting the immunization data on MMR (18206 doses) till Oct 2014, though MMR is not a part of UIP program in the state.

Chhattisgarh

- Low coverage of Hep B Birth dose (70.8%) against institutional deliveries.
- ♠ Low Coverage of Measles second dose (38.7%) and DPT Booster (44.0%) against expected (58.3%).
- State is also reporting the immunization data on MMR (418 doses) and JE 1st (345 Doses), JE 2nd (5 Doses) till Oct 2014, though MMR & JE is not a part of UIP program in the state.

Jharkhand

- ♦ Low coverage of Hep B Birth dose (54.9%) against institutional deliveries.
- ♦ Low coverage of Measles first dose (46.5%), Measles second dose (34.0%), Full Immunization (45.1%), DPT Booster (36.7%), JE 1st Dose (6.0%) and JE 2nd Dose (3.2%) against expected (58.3%).
- ♦ More than 5 % Planned RI Session not held till Oct 2014.
- State is also reporting the immunization data on MMR (708 doses) till Oct 2014, though MMR is not a part of UIP program in the state.

Madhya Pradesh

- ♦ Low Coverage of BCG (41.0%), DPT1 (42.8%), DPT3 (41.7%), Hep B3 (41.5%), Measles first dose (44.4%), Measles second dose (25.7%), Full Immunization (42.6%) and DPT Booster (36.3%) against expected (58.3%).
- State is also reporting the immunization data on MMR (810 doses) and JE 1st (555 Doses), JE 2nd (4 Doses) till Oct 2014, though MMR & JE is not a part of UIP program in the state.

Odisha

- ♠ Low coverage of Hep B Birth dose (73.9%) against institutional deliveries.
- ♠ Low Coverage of Measles second dose (42.9%) and DPT Booster (43.5%) against expected (58.3%).
- DPT1-DPT3 dropout rate is negative (-1.1%) mostly from Anugul (-6.8%), Ganjam (-6.4%). Negative drop out means that the reported DPT3 coverage is higher than the DPT 1 coverage.

Rajasthan

- Total 01 district (Pratapgarh) out of 33 districts did not report for the month of Oct-14.
- ▶ Low coverage of Hep B birth dose (66.2%) against institutional delivery.
- ♦ Low coverage of DPT1 (45.9%), DPT3 (44.4%), Hep B3 (43.9%), Measles first dose (45.9%), Measles Second Dose (11.7%), FIC (44.8%) and DPT Booster (33.1%) against expected coverage (58.3%).
- State has reported 15 Polio Case from Jaipur district.
- State is also reporting the immunization data on MMR (370843 doses) and JE 1st (331 Doses) till Oct-14 2014, though MMR & JE is not a part of UIP program in the state.

Uttar Pradesh

- ♦ Low coverage of HepB birth dose (53.9%) against institutional delivery.
- ♠ Low coverage of DPT 3 (46.5%), Hep B3 (45.3%), Measles second dose (23.2%), DPT Booster (36.9%), JE 1st Dose (29.5%) and JE 2nd Dose (38.2%) against expected (58.3%).
- ♦ State has reported 4268 cases of Diptheria and 16790 cases of Measles and which is highest in the Country and 441 cases of Pertusis which is second highest in the Country and 131 cases of Tetanus Neonatarum which is third highest in the Country.
- State is reporting the immunization data on MMR (71471 doses) till Oct 2014, though MMR is not a part of UIP program in the state.

Uttarakhand

- ♠ Low coverage of HepB birth dose (56.1%) against institutional delivery.
- ♦ Low coverage of Measles Second Dose (45.5%), JE 2nd (46.5%) against expected (58.3%).
- More than 5 % Planned RI Session not held till Oct 2014.
- State has reported 4 Polio Case from Dehradun district.
- State is reporting the immunization data on MMR (62 doses) till Oct 2014, though MMR is not a part of UIP program in the state.
